The teaching statement must be supported by a portfolio of evidence which may be requested from short listed candidates at the interview.

- Applicable qualification at NQF level 9 for an academic area (e.g., MPhil, Master's Degree either through coursework or research) plus CA(SA); or
 - In the absence of a CA(SA) an applicable qualification at NQF level 10
- Three years applicable practical experience (e.g. traineeship or a minimum of three years of discipline related work experience)
- Good theoretical knowledge of the discipline
- · Excellent communication skills

- Teaching experience will be an advantage

Post specific requirements for the Forensic Auditing position in the Department of Auditing for Senior Lecturer:
