The Beginnings of 'Tshokollo ya Setšhabeng'

In a small coffee shop meeting that took place on 22 July 2022, Dr Francois Louw and Prof Kevin Sibanyoni sparked a conversation that would eventually lead to the creation of a ground-breaking engaged scholarship project. Over cups of coffee, these visionaries shared their ideas and laid the foundation for 'Tshokollo va Setšhabeng,' project aimed at transforming the lives formerly incarcerated individuals.

Since that inspirational meeting, more likeminded colleagues from the College of Law have eagerly joined the team, each sharing the same vision for the project's impact. 'Tshokollo ya Setšhabeng,' which translates to 'corrections in the community,' is an engaged scholarship project that brings together an interdisciplinary group of researchers. community corrections practitioners, offenders (parolees and probationers), and community members. The team includes esteemed individuals such as Prof Thabiso Matshaba, Ms. Nomalanga Mnisi, Mr. Charles Kgoale, Prof Willem Luyt, Prof Nicolien du Preez, Mr. Joseph Hlatshwayo, Ms. Unathi Poyo, Dr. Aaron Labane, and Ms. Neo Masemene. Together, they focus on vital issues surrounding the social reintegration of offenders, the community corrections environment, and recidivism.

To encapsulate their vision and values, the 'Tshokollo ya Setšhabeng' team has created a distinct identity for their project. A bird soaring free from a broken chain serves as a powerful symbol of a person released from incarceration, reintegrating into society. The outstretched hand represents the unwavering support and



acceptance from the community, while the sun in the background symbolizes renewal and hope for a brighter future.

Meet the Boss of Community Corrections

We are thrilled to introduce a remarkable individual, **Mr Phiko Frank Mbambo**, the Chief Deputy Commissioner (CDC) of Community Corrections at the Department of Correctional Services (DCS). With over 24 years of experience in the Criminal Justice field, Mr. Mbambo is a dedicated leader focused on transforming the Community Corrections system in South Africa.





Childhood Dreams and Career Path

Born and raised in East London, Mr. Mbambo hails from a large family in the town of Debe-Nek in the Eastern Cape. Growing up, he had a passion for the law and initially pursued a career in legal studies. However, during his time at the University of Fort Hare, he discovered his love for Criminology, specifically community policing and community corrections. This newfound interest led him to shift his focus and complete a Bachelor of Arts Degree in Criminology and History in 1991. He continued his studies in the field, earning a postgraduate Higher Diploma in Education and an Honours Degree in Criminology in 1993. He also holds a Postgraduate Certificate in Executive Leadership and a Certificate in Security Management. Currently, Mbambo is pursuing a Master of Arts Degree in Criminology with the University of Fort Hare.

Mr. Mbambo's career journey began in 1992 when he worked as a teacher at Mpumzi High School in the Eastern Cape. He later served as a lecturer in the Department of Criminology at the University of Fort Hare from January 1994 to March 1995.

Over the years, Mr. Mbambo held various positions in different government departments related to safety and security at both the national and provincial levels.

His experience includes working in the South African Police Services Crime Intelligence Unit at the level of a Major (April 1995 - September 1996), Deputy Director: Crime Prevention at the National Civilian Secretariat for Police (October 1996 - May 1999), Director: Community Police Relations in the Provincial Government of Gauteng (Department of Safety) Community (June 1999 November 2005). In addition, he served as Chief Director: Security Management in the Provincial Government of the Western Cape (Department of Community Safety) from December 2005 to June 2009. These experiences equipped him with a comprehensive understanding of the criminal justice system and the intricacies of community corrections.

Leadership Roles in DCS

Since joining the DCS in 2009, Mr. Mbambo held several has senior management positions. He began his journey as the Deputy Commissioner for Executive Management (July 2009 -September 2010) before taking on roles such as Deputy Commissioner of Inter-Governmental Relations (October 2010 -May 2016). Deputy Regional Commissioner and Acting Regional Commissioner: Limpopo, Mpumalanga and North West Region (June 2016 - April Regional Commissioner: 2019), and Eastern Cape Region (May 2019 - April 2021). In April 2021, he acted as the Chief



Operations Commissioner for DCS before assuming his current position as CDC of the Community Corrections Branch on January 1, 2022.

Between November 2013 and March 2015, Mr. Mbambo also served as the Principal Officer of the African Correctional Services Association (ACSA) in the continent. His work involved organizing the **ACSA** Biennial Conference in the ACSA Mozambique, Ministerial Consultative Forum in South Africa, and the ACSA Executive Committee meetings in South Africa, Zambia, Uganda, Namibia, Tanzania, and Mozambique for members States. During his term, he also established the ACSA Secretariat and Governance Structure: reviewed the ACSA Constitution; and developed the Strategic Plan and Code of Conduct for ACSA.

Defining Community Corrections Under Mr. Mbambo's Leadership

Community Corrections plays a vital role in the rehabilitation and reintegration of offenders into society. Mandated by legislation aligned with the new strategic direction of DCS and the White Paper on Corrections (2005),the Community Corrections system focuses on the conditional placement of offenders outside correctional centres. This includes parole, day parole, medical parole, placement correctional under supervision, and Awaiting Trial Persons.

As the CDC of Community Corrections, Mr. Mbambo is responsible for developing and implementing strategies to make the Community Corrections system more impactful. This involves forging strategic partnerships with various stakeholders, such as government departments, business sectors. civil society organizations, non-profit organizations, institutions. and tertiary Noteworthy partnerships include the Memorandum of Understanding with the National House of Traditional and Koi-San Leaders, which aims to strengthen the implementation of social the reintegration programme. Additionally, collaborations with tertiary institutions such as UNISA's Department of Corrections Management, demonstrate Mr. Mbambo's commitment to leveraging research, knowledge sharing, and best practices, to make a tangible difference in the Community Corrections system. By resourcing and professionalizing the Community Corrections Branch, Mbambo aims to reposition the system and market the social reintegration programme effectively to the communities it serves.

At the heart of the social reintegration programme lies the elevation of victims of crime within the Community Corrections system. This is achieved through increased participation in the restorative justice programme, which incorporates Victim-Offender Dialogue (VOD). By offering offenders opportunities to reflect on their



actions and seek forgiveness, Mr. Mbambo believes that the rehabilitation and reintegration process can be significantly strengthened. In addition to promoting restorative justice, the social reintegration programme provides for the economic empowerment of parolees, probationers, and victims through skills development and training programmes. By equipping individuals with the necessary skills, they become better prepared to seek employment, or become entrepreneurs, fostering self-sufficiency and reducing the likelihood of re-offending, according to Mr. Mbambo.

One of the key strategies guiding Mr. Mbambo's work is the Social Reintegration Framework (SRF). The SRF is a guiding document within the DCS that aims to prepare offenders for social acceptance and effective reintegration into their communities while on parole, or under community correctional supervision. The primary objective of the SRF is to drive the implementation of the social reintegration programme of DCS and reposition

community corrections within the criminal justice system. To achieve this objective, Mr. Mbambo and his team are enhancing existing strategic partnerships establishing new partnerships with relevant stakeholders. The goal is to mobilize stakeholders to actively participate in community corrections and contribute to the rehabilitation and social reintegration of offenders. To facilitate this process, coordinating mechanisms and structures have been established. For example, community corrections forums are currently being set up at the local level to assist in the implementation of social reintegration initiatives. These forums will serve as collaboration platforms for and engagement between the DCS and local communities.

Mr. Mbambo's dedication to the field of community corrections is commendable. With his wealth of experience, strategic mindset, and commitment to societal change, he is leading the way in transforming the Community Corrections system in South Africa.

Revive Initiatives - Building Through Giving

Revive Initiatives is a remarkable Non-Profit Organization (NPO) dedicated to rehabilitating and reintegrating parolees and ex-offenders into our communities. Founded by David Heritage, an ex-offender himself, Revive has been making a significant impact in the East Rand community of Gauteng since its inception in 2017.

David, with his first-hand experience of the challenges faced by individuals transitioning from incarceration to society,





has been a driving force behind Revive's mission. With a postgraduate degree in Theology Specialization in Community Development and over a decade of experience working with parolees, David's passion for serving the community and helping the poor and disadvantaged is truly inspiring. His organization, Revive Initiatives. his is а testament to commitment.

At the core of Revive's efforts are two remarkable programmes: the parolee and ex-offenders programme and the food outreach programme. These two programmes have proven to be invaluable in positively transforming communities.

The parolee and ex-offenders programme, established in 2017, is designed to provide support and guidance to individuals in their journey of rehabilitation and reintegration. Revive utilizes a support group model, where parolees meet monthly to participate in skills development, mentorship programmes, explore and to selfemployment opportunities. These support groups serve as safe spaces where participants can openly discuss their reintegration challenges, seek advice from one another. and receive encouragement they need to succeed. Additionally, Revive offers small business development courses and skills training, empowering its members to become selfsufficient and contributing members of

society. David envisions expanding these services by establishing community skills development centres in partnership with organizations operating in the corporate social investment space.

food outreach programme was initiated in 2020 in response to the escalating unemployment rate and the subsequent increase in displaced families and homelessness. Every week, Revive collects and distributes over 500 kilograms of quality food to those in need. By collaborating with Community Corrections offices leveraging and technology platforms such as WhatsApp and other social media formats, Revive ensures that individuals are not only provided with nourishing meals but also receive ongoing support and care. "Although we currently provide over 2000 meals a week to various individuals and struggling families, the need for assistance remains," David 2023. acknowledges. Since January Revive has distributed a staggering 50,000 meals, and their commitment to helping the

community shows no signs of waning. Monthly food parcels are handed over to Community Corrections offices, benefiting parolees under their care.
