# Top African jurists to converge at the University of South Africa (Unisa) to discuss the African Continental Free Trade Agreement

The crème de la crème of the legal profession on the African continent, under the auspices of the African Bar Association (AFBA) will converge on the main campus of the University of South Africa (Unisa) in Pretoria for the 2023 Annual AFBA Conference to be held from 06 - 10 August 2023.

The Minister of Justice and Correctional Services of South Africa, **the Honourable Ronald Lamola**, the Chief Justice of the Republic of South Africa, **Justice Raymond Zondo** and the Principal and Vice Chancellor of Unisa, **Professor Puleng LenkaBula** are amongst some of the key speakers during the opening ceremony on Monday, 7 August 2023.

Other speakers include the Chief Justice of the Republic of Sierra Leone, His Lordship Honourable Justice Desmond B. Edwards, the President of the African Bar Association (AFBA), Mr Hannibal Egbe Uwaifo, Esquire; as well as the Chairperson of the South African Bar Association (SABA), Advocate Bart Ford

The President of the Republic of Ghana, **His Excellency Nana Akufo-Addo**, a previous Attorney-General of Ghana (2001-2003), will also attend the conference.

The conference will be hosted by AFBA in partnership with Unisa and will be held under the theme: *'Building the legal profession in Africa under the African Continental Free Trade Agreement (AfCFTA)''*. This is an apex gathering of the association, which comprises lawyers from across the African continent, and is designed to discuss concrete and emerging developments affecting the rule of law, the legal profession and African development.

The 2023 conference brings under one roof leading experts on law, the legal profession and Africa trade to critically discuss African trade and the evolving legal regime under the AfCFTA; with a view to evaluating current dynamics and prospects of the regime.
