to understand professionalism as a qualified practice in the given context. In general, professionalism can be defined as a way of perceived, accepted or legitimized, systematic conduct, expertise, formats, patterns, proficiencies, practices, structures, etc. With professionalism inherently embedded are dynamic, formality, functionality, legitimacy, operationalisation, organization, proactiveness, production, structures, systems, etc. with a degree of entrusted autonomy, competency/expertise, and proficiency.

Cardinal Features of Professionalism¹¹:

Notable characteristics: Explicitly stipulated accountability, attitude, behavior, certification (accreditation), commitment, compassion, confidence, courtesy, emotional intelligence, freedom, humility, know-how, norms, respect, self-regulation, skills, social responsibility, sympathy, trust, value.

Identity domain: defined (recognized) autonomy, competence/expertise, credibility, ethics and integrity, independence, impartiality, manner, qualification quality, reliability, standard of practice, truth.

Practices (overt and covert) domain: systematic (able, coordinated, effective, efficient, etc.) execution, organization, plan, review/evaluation, and professional development (updates).

Distinctiveness of Scholarly Professionalism: Scholarly professionalism exhibits inherent peculiarities. As general expectation and rule, it is presumed that highest possible intellectual ... Systematic advancement of scientifically rationalized (reasoned) set of *par excellence* explicit ethics, critical curiosity, philosophy, principles/values, evidence-lead know-how proficiency norms, and imparting same (i.e., *science*, *solutions*, and *services* continuum¹²) with the life-long learning in a defined stream.

The Contemporary Scholarly Discourses and the Envisioned Future Landscape: Among others scholarly taxonomies such as 'Excellence', Life-Long Learning, Role-Modeling and similar frameworks are not uncommon in the contemporary scholarly discourse. Overall, the "Power of Knowledge" is presumed to stand at the highest demand to the unlimited future. Of course, the significance of knowledge-based competency and application is presumed to be embedded with the aforementioned. It also is worthwhile to appreciate the ongoing debates surrounding the noted taxonomies. Moreover,

"The global research and innovation system is highly competitive and narrowly focused on a set of short-term criteria for excellence, and often those criteria are imposed at the individual level rather than across a portfolio of activity. That creates incredible pressure on individuals and a stovepiping that segregates different parts of the system—research from innovation, and both from the wider society."

The multifaceted implications for the scholarly professionalism are believed to be crystal clear and thus instructive with this incisive enough statement, though.
