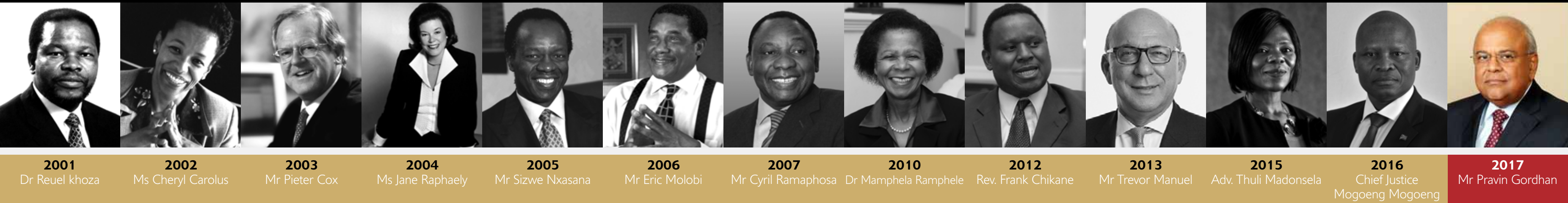


Leadership in Practice Award

The intention is to recognise the contributions of outstanding female leaders and up-and-coming young leaders who exemplify the SBL vision, values and leadership model.

As with the LIP Award, the two new awards will be presented in recognition of the visible business and leadership achievements of the recipients, as well as the equally important intangible elements that distinguish them from their peers. Such intangible qualities would include the ability to inspire people to strive towards a clearly articulated vision and to embody the principles of integrity, transparency and accountability in their business dealings and other spheres of life.

NOMINEES FOR THE EMERGING LEADER AWARD:

(Candidates must be 35 years old or younger, and Unisa or Unisa SBL alumni. Please include the person's qualification with your nomination)

VISION	Ability to steer business and economic activities towards future prosperity.
VALUES	Be able to demonstrate good ethics and integrity in her business environment.
INFLUENCE	The ability to influence and inspire excellence in business.
RESULTS	The achievement of sustainable business growth and economic development.
CONTRIBUTION TO THE COMMUNITY	Ability to empower the community, more especially women and previously disadvantaged/marginalised groups.
EMERGING LEADER AWARD	
REQUIREMENTS AND CRITERIA	The nominee must be at least 35 years old or younger, and a UNISA/SBL Alumni.
VISION	The ability to set a stimulating future vision that will empower the youth in a sustainable environment.
VALUES	Be able to demonstrate good ethics and integrity in her business environment.
INFLUENCE	The ability to influence and inspire excellence in business.
RESULTS	The achievement of sustainable business growth and economic development.
CONTRIBUTION TO THE COMMUNITY	Ability to empower the community, more especially women and previously disadvantaged/marginalised groups.
